Steni Protego Sand is a robust stone-composite panel with a smooth surface designed for use as exterior ventilated roof-cladding on all types of buildings. The panels consist of several layers of materials that are hardened and cured to give durability and a long-lasting surface.

Steni Protego Sand comes in standard formats 1195x1195mm and 595x595mm. In addition panes for right/left and top/bottom of the roof is available.


The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.


